



State Team Selection Policy

This policy sets out the Judo Tasmania State Team selection criteria.

This policy applies to the selection of members to represent Judo Tasmania as part of the State team in the Judo Australia National Championships.

The team selection process is performed on an annual basis.

SELECTION CRITERIA

1. State Training

Competitors must participate in the State training sessions during the pre-nationals training cycle.

2. Judo Tasmania competition participation

Competitors must have competed in:

- The most recent Tasmanian State Titles; and
- A minimum of two Tasmanian competitions (in addition to State Titles) that occur in the twelve month period between National Championships.

3. Australian National Event Series

In order to demonstrate capability at the National level the competitor should compete in:

- One International Open in the National Event Series.

4. State Coach's confirmation

Competitor must receive:

- Acceptance by the State Coach that the competitor is suitable for nomination to represent Judo Tasmania at the National Championships.

EXEMPTIONS FROM CRITERIA

1. Injury has been sustained that prevented the competitor from achieving one or more of the selection criteria.

- *Evidence required:* Medical Certificate.
- *Resolution process:* Medical clearance to compete is required where necessary and State Coach confirmation (as per selection criteria) required.

2. Work/School commitments have arisen that prevented the competitor from achieving one or more of the selection criteria.

- *Evidence required:* Letter from employer/school.
- *Resolution process:* Evidence of supplementary training required with sign off from an accredited Judo Tasmania Coach and State Coach confirmation (as per selection criteria) required.

3. Family circumstances have arisen that prevented the competitor from achieving one or more of the selection criteria.

- *Evidence required:* Letter outlining circumstances to State Coach.
- *Resolution process:* Evidence of supplementary training required with sign off from an accredited Judo Tasmania Coach and State Coach confirmation (as per selection criteria) required.

4. Overseas/Interstate training and/or competition

- *Evidence required:* Letter outlining details of training/competition to State Coach.
- *Resolution process:* State Coach confirmation (as per selection criteria) required.

5. Financial consideration have arisen that prevented the competitor from achieving one or more of the selection criteria.

- *Evidence required:* Letter outlining circumstances to State Coach.
- *Resolution process:* Evidence of supplementary training required with sign off from an accredited Judo Tasmania Coach and State Coach confirmation (as per selection criteria) required.

All evidence to be forwarded to the Head Coach, Priscus Fogagnolo **BEFORE** advertised state training session.
