Background information: RevSport has been in operation for over twelve months and each club administrator has access to their own club details with the current board members having full admin access to all areas. The registration of members are now conducted as an online credit card payment with an instant acknowledgement of payment by email. Reminders for renewal are emailed automatically at 30, 14 and 1 day from expiry. Currently the treasurer is still writing out physical receipts and posting to club administrators. They are issued to stick into each judokas registration book as proof of registration. This system of proof is not needed now that we have digital access to each members expiry dates. A full list of current members will be printed out by the treasurer a day before a competition and given to each competition organiser. To be available at registration for checking of current membership status.
